- (H) All the executive and administrative powers shall be vested in the Managing Trustee and the same may be delegated by him to other Trustee in writing for a period to be decided by the Managing Trustee/Chairman.
- (I) All the bank accounts of the Trust will be jointly operated by the Managing Trustee/Chairman and Trustee/Secretary of the Trust. Any type of Bank Account in the name of unit/division shall be operated by the Trustee/s or the Authoritations of
