





Ram Krishna Nagar, Patna-800027, shall be the Managing Trustee/Chairman of the Trust for life to continue. In case he wishes to relinquish his respective post, he will have the right to nominate his offspring hold his post. In case of sudden death of the Managing Trustee his post will be filled up as per term and conditions laid down in the Byelaws of Trustee.
- (H) All the executive and administrative powers shall be vested in the Managing Trustee and the same may be delegated by him to other Trustee in writing for a period to be decided by the Managing Trustee/Chairman.
- (I) All the bank accounts of the Trust will be jointly operated by the Managing Trustee/Chairman and Trustee/Secretary of the Trust. Any type of Bank Account in the name of unit/division shall be operated by the Trustee/s or the ~~Authorised~~ persons of the Trustee.

- (J) ~~The Trust will apply whole/part~~ of the income of the Trust Fund or accumulation here to any one or more of the objectives of the Trust.
- (K) The Trust will accept any donation, contribution and grant from any person, organization, Govt. & Semi Govt. sector.
- (L) The Trust will act through resolutions taken by the Board of Trustees passed by mutual consent. If it is not possible then it can be done by simple majority in order to achieve the aims and objectives of the Trust in conformity with Indian Trust Act and other laws of the land in force.
- (M) Any Amendment can be made in the terms and conditions, objectives and aims and title of this present deed, Such amendment will come into effect after the signature of the Managing Trustee/Chairman.
- (N) The Trust shall be empowered to take over any other charitable Trust, society, association, institution or organization for fulfilling the similar objective.
- (O) The Trustee may from time to time frame rules for the conduct and regulations of the meeting of Trustees. In absence of such regulation one-two (1/2nd) of the Trustees shall form the quorum of the meeting. All the meeting of the Trustees shall be called by the Managing Trustee of the Trust and will be attended by him.
- (P) Annual accounts of the Trust shall be regularly maintained and audited by a Chartered Accountant every year. The accounting year of the Trust shall be from 1st April to 31st March every year.

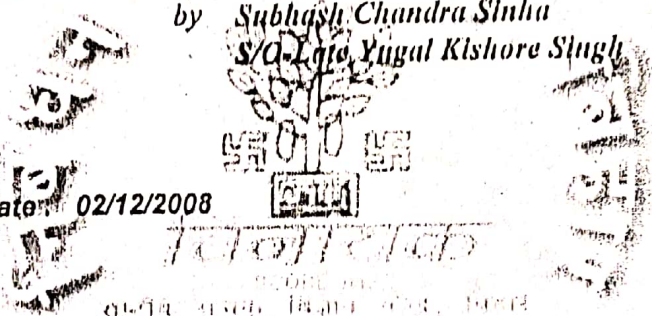
